

Hold Harmless, Assumption of Risk, Waiver, Release of Liability, and Indemnification for a Minor Child Participant in SoaringNV, LLC Activities

SoaringNV, LLC (SoaringNV) requires that all Parents/Guardians of a Minor Child Participant (referred herein to as the "Minor Child") read and sign this Hold Harmless, Assumption of Risk, Waiver, and Release of Liability, and Indemnification Agreement (herein referred to as "Agreement"):

THE "UNDERSIGNED," BEING AT LEAST 18 YEARS OF AGE, HEREBY REPRESENTS THAT HE/SHE IS THE PARENT OR LEGAL GUARDIAN OF THE IDENTIFIED MINOR CHILD NAMED BELOW AND THAT THE UNDERSIGNED HAS THE RIGHT TO MAKE DECISIONS CONCERNING THE CARE, CUSTODY, AND CONTROL OF THE MINOR CHILD. THE UNDERSIGNED UNDERSTANDS THAT THE CHILD'S PARTICIPATION IN ANY AND ALL ACTIVITIES OF SOARING NV, LLC MAY INVOLVE THE RISK OF PHYSICAL INJURY, INCLUDING DEATH, AND PROPERTY DAMAGE.

I understand and hereby acknowledge that my Minor Child desires to participate in Activities of SoaringNV. I further understand and acknowledge that the Activities of SoaringNV are potentially dangerous and necessarily entail the risk of bodily injury, death and property damage. Flights could result in injuries from a combination of factors including but not limited to: mechanical failure, limitations of the aircraft, air traffic control issues, unfavorable weather or terrain conditions, pilot or operational error, or other causes. Notwithstanding these risks and other hazards of flying in small aircraft which may be foreseeable but not specifically identified herein, **I understand and acknowledge that I will expressly and voluntarily assume all risks** and full responsibility on behalf of the Minor Child for any bodily injury, death, or property damages out of or related to a SoaringNV activity.

I understand and hereby acknowledge that by signing this Agreement, I on behalf of myself, my Minor Child and our agents, successors, executors, administrators, and third party beneficiaries forever, completely and irrevocably release, discharge, indemnify, defend, hold harmless, and waive any and all claims against SoaringNV and its members, directors, officers, agents, employees, attorneys, volunteers, insurers, heirs, assigns, successors in interest, executors, administrators, representatives, third party beneficiaries ("Released Parties") who are acting officially or otherwise, from any and all liability, damages, lawsuits, actions, causes of action, claims, claims for relief, demands, fees, expenses, and costs of any kind whatsoever, including attorneys' fees, as well as any and all claims relating to all known and foreseeable claims and all unknown and unforeseen claims against any of the Released Parties relating to personal injuries to the Minor Child and incurred by the Minor Child arising from or in any way related to a SoaringNV activity, or the cancellation or delay of a SoaringNV activity. **Further, I specifically agree that should SoaringNV be sued for any act arising out of my minor child's participation in this Activity, I personally will defend at my cost and fully indemnify SoaringNV.**
